### **RESOLUTION CC 2019-14**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GLENDORA, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON MARCH 5, 2019, DECLARING THE RESULT FOR MEASURE "E" ADOPTED BY THE VOTERS AND CERTIFYING THE ELECTION RESULTS

# THE CITY COUNCIL City of Glendora, California

THE CITY COUNCIL OF THE CITY GLENDORA DOES HEREBY RESOLVE AS FOLLOWS:

**WHEREAS**, a General Municipal Election was held and conducted in the City of Glendora, California, on Tuesday, March 5, 2019, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

**WHEREAS**, the County Election Department canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit A."

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GLENDORA, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

**SECTION 1**. That the whole number of votes (ballots) cast in the precincts except *vote by mail* voter ballots and provisional ballots was 2,034.

That the whole number of *vote by mail and provisional voter ballots* cast in the City was 4,563, making a total of 6,597 (20.78%) ballots cast in the City.

**SECTION 2.** That the following questions, which was designated as Measure "E", was submitted to Glendora registered voters at the March 5, 2019 Special Municipal Election as follows:

To maintain existing City services including public safety, youth/adult programs, fix streets/potholes, address quality of life issues, maintain library services, address rising pension costs, implement technology projects, and improve the financial health of the City, shall the Measure be adopted approving an ordinance enacting a three-quarters percent	YES
(0.75%) transactions and use tax providing approximately \$5,000,000 annually in general revenue, to be levied until ended by the voters with all funds staying local, for Glendora?	NO

**SECTION 3.** That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates were as listed in Exhibit "A" attached.

**SECTION 4.** The City Council does declare and determine that as a result of the election: With the number of votes for Measure E reaching 53.67%, the measure does carry and the proposed Ordinance shall go into effect.

**SECTION 5.** The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing: (1) The whole number of \*votes (ballots) cast in the City; (2) The measure voted upon; (3) The number of votes given at each precinct for and against the measure; and (4) The total number of votes given for and against said measure.

**SECTION 6.** That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

**SECTION 7.** That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
