A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GLENDORA, CALIFORNIA, PROVIDING FOR THE APPOINTMENT OF THE OFFICE(S) OF THE CITY OF GLENDORA THAT WERE TO BE ELECTED ON TUESDAY, MARCH 3, 2020 AND PROVIDING FOR THE FOLLOWING APPOINTMENTS OF MEMBERS OF THE CITY COUNCIL: GARY BOYER REPRESENTING DISTRICT 3, AND MENDELL THOMPSON REPRESENTING DISTRICT 5 EACH FOR FULL TERM OF FOUR-YEAR

# THE CITY COUNCIL City of Glendora, California

## THE CITY COUNCIL OF THE CITY OF GLENDORA DOES HEREBY RESOLVE AS FOLLOWS:

**WHEREAS,** as set for on Resolution CC 2019-58, three (3) City offices are subject to election on March 3, 2020 - three (3) Members of the City Council representing Districts 2, 3, and 5 for the full term of four years; and

WHEREAS, pursuant to § 10229 of the Elections Code of the State of California, as of the close of the nomination period on December 6, 2019 for the of office of two (2) Members of the City Council representing District 3 and District 5 that there are not more candidates than offices to be elected and that § 10229 of the Elections Code allows one of the following courses of action to be taken by the City Council:

- 1. Appoint to the office the person who has been nominated.
- 2. Appoint to the office any eligible voter if no one has been nominated.
- 3. Hold the election if either no one or only one person has been nominated.

**WHEREAS,** a notice was posted on December 6, 2019 and published on December 12, 2019, in the San Gabriel Valley Tribune, a newspaper of general circulation pursuant to law.

# NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GLENDORA, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

**SECTION 1**. That pursuant to § 10229 of the Elections Code of the State of California, the following action is being take:

(a) The following persons are hereby appointed to the offices to which they were nominated, and are deemed to have been duly elected to such offices, pursuant to § 10229(a)(3) of the Elections Code:

NAME	OFFICE	DISTRICT	TERM
Gary Boyer	Member of the City Council	District 3	4 years
Mendell Thompson	Member of the City Council	District 5	4 years

**SECTION 2.** The Consolidated General Municipal Election scheduled to be held on Tuesday, March 3, 2020 for the offices of City Council, District 3 and 5, is, by this action, hereby canceled.

**SECTION 3.** The foregoing persons appointed to said offices shall qualify and take office and serve exactly as if the same had been duly elected at a March 3, 2020 General Municipal Election for the office.

**SECTION 4**. That the City Clerk is directed to file an "certified copy" of this Resolution with Los Angeles County Registrar Recorder, Elections Division, 12400 Imperial Highway, Norwalk, CA 90650.

**SECTION 5.** The City Clerk shall certify to the passage and adoption of this resolution, shall enter the same in the Book of Original Resolutions.
