

RESOLUTION CC 2012-77

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GLENDORA, CALIFORNIA, PROVIDING FOR THE APPOINTMENT TO THE OFFICE(S) OF THE CITY OF GLENDORA THAT WERE TO BE ELECTED AND CANCELLING THE ELECTION TO BE HELD ON TUESDAY, MARCH 5, 2013.

THE CITY COUNCIL OF THE CITY OF GLENDORA DOES HEREBY RESOLVE AS FOLLOWS:

WHEREAS, as set for on Resolution CC 2012-65, two City offices are subject to election on March 5, 2013 - two (2) Members of the City Council for the full term of four years; and

WHEREAS, pursuant to § 10229 of the Elections Code of the State of California, as of the close of the nomination period on December 7, 2012, there are not more candidates than offices to be elected and that § 10229 of the Elections Code allows one of the following courses of action to be taken by the City Council:

1. Appoint to the office the person who has been nominated.
2. Appoint to the office any eligible voter if no one has been nominated.
3. Hold the election if either no one or only one person has been nominated.

WHEREAS, a notice was posted on December 7, 2012 and published on December 12, 2012, in the San Gabriel Valley Tribune, a newspaper of general circulation pursuant to law.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GLENDORA, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That pursuant to § 10229 of the Elections Code of the State of California, the following action is being taken:

- (a) The following person(s) is/are being appointed to the office(s) to which he/she/they were nominated, and is/are considered to be the same as being elected, pursuant to § 10229(a)(3) of the Elections Code:

<u>NAME</u>	<u>OFFICE</u>	<u>TERM</u>
Karen Davis,	Member of the City Council	4 years
Gene Murabito	Member of the City Council	4 years

SECTION 2. The election scheduled to be held on Tuesday, March 5, 2013, is now cancelled.

SECTION 3. The person(s) appointed, if any, shall qualify and take office and serve exactly as if elected at a municipal election for the office.

SECTION 4. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.


