



Hi Valerie.

I'm following up with a concept layout that shows how an 1/2 acre site can support a transitional housing community of 28 Pallet Ensuites with communal amenities and spaces. Attached as well is a sample quote of what the costs to procure Pallet ensuite through the State procurement process. It would be an additional \$130k. to purchase directly from Pallet our laundry room, community structure, admin office, and assembly services. Lastly, I've included an overview of Pallet ensuite (if ordered directly from Pallet) to give you an idea of the product. The CA procured Pallet Ensuite is very similar with the main difference being that CA procurement is a bundle deal that includes all the optional features.
