#### UPCOMING STREET IMPROVEMENT PROJECTS FY 2021-2023

### Plan 1327: Bender, Carter et al- Street Improvement

This project will resurface 225,000 square feet of pavement with rubberized asphalt, approximate 2.23 lane miles on S Bender Ave, W Carter Ave, S Washington Ave, Pennsylvania Ave, S Vermont Ave, and W Newburgh St. Damaged sidewalk, curb, gutter and curb ramps will also be replaced in the project area. This project will provide a new smooth street to the residents, reducing maintenance costs and elevating the appearance of the area.

Fund allocated for this street improvement project is \$685,600.

## Plan 1338 & 1339: Bennett Ave et al-Street Improvement.

This project will resurface 311,000 square feet of street improvements, approximately 2.33 lane miles on Bennett Ave, Washington Ave, Westridge Ave, and Bender Ave. Street improvements include, but not limited to, pavement rehabilitation, concrete sidewalk repairs, curb and gutter repairs, ADA compliant curb ramps, traffic signal loop replacement, signing, and striping. This project will include a striping concept which will incorporate marked bike lanes. Street improvement plans should include sufficient details necessary for constructions, including typical sections. This project will provide a new smooth street to the residents, reducing maintenance costs and elevating the appearance of the area.

Fund allocated for this street improvement project is \$1,396,500.

### Plan 1346 & 1347: Mauna Loa Ave, East of Glendora – Street Improvement

This project resurfaces 211,000 square feet of street improvement, approximately 1.96 lane miles on E Mauna Loa Ave, E Linfield St, E Duell St, S Minnesota Ave, and Langham Ave. Street improvements include, but not limited to, pavement rehabilitation, concrete sidewalk repairs, curb and gutter repairs, ADA compliant curb ramps, signing, and striping. This project will provide a new smooth street to the residents, reducing maintenance costs and elevating the appearance of the area.

Fund allocated for this street improvement project is \$1,249,500.

# Plan 1341-1345: Cumberland Road, Palomar Drive, Lone Hill Avenue (North of Foothill Boulevard), Amelia Avenue, Country Club Drive, and Country Club Vista- Street Improvement

This project resurfaces 211,000 square feet of street improvement, approximately 1.81 lane miles on Cumberland Rd, Palomar Dr, Lone Hill Ave North of Foothill Blvd. Street improvements include, but not limited to, pavement rehabilitation, concrete sidewalk repairs, curb and gutter repairs, ADA compliant curb ramps, signing, and striping. Additionally, this project includes improvements to address drainage issues on Amelia Ave by adding a gutter on its westerly side. This project will provide a new smooth street to the residents, reducing maintenance costs and elevating the appearance of the area.

Fund allocated for this street improvement project is \$1,020,780.

## Plan 1328: St. Vladimir Street et al – Street Improvement

The project resurfaces 141,115 square feet of street improvements, approximately 1.39 lane miles on St. Vladimir Street, Cossacks Place and Lawford Street. Street improvements include, but not limited to, pavement rehabilitation, concrete sidewalk repairs, curb and gutter repairs, ADA compliant curb ramps, signing, and striping. This project will provide a new smooth street to the residents, reducing maintenance costs and elevating the appearance of the area.

Fund allocated for this street improvement project is \$407,000.

## Plan 1350: FY2021-22 Citywide Slurry Seal Project

This project applies Type II slurry seal treatment to 608,433 square feet, approximately 5.82 lane miles of streets. The weight average PCI value of the project area is 60.21 and fall within the recommended range to be maintained by slurry seal treatment. Slurry Seal treatment helps to restore skid resistance and aesthetic appeal of the streets and its life-cycle is averaging 4 to 5 years. Slurry Seal treatment will be applied to various local streets including Hidden Springs Ln, Pebble Springs Ln, Fountain Springs Ln, Indian Springs Dr, Quail Springs Pa St, Fawn Springs Ln, E Palm Dr, Willow Springs Ln, Boulder Springs Dr, Dalton Springs Ln.

Fund allocated for this street improvement project is \$200,000.

## FY 2022-23 Citywide Slurry Seal Project

This project applies Type II slurry seal treatment to 561,084 square feet, approximately 5.35 lane miles of streets. Slurry Seal treatment helps to restore skid resistance and aesthetic appeal of the streets and its life-cycle is averaging 4 to 5 years. Slurry Seal treatment will be applied to various local streets including S Elwood Ave, E Caroll Ave, Cedarwood Ave, Pflueger Ave, N Worthy Dr, Underhill Dr, E Comstock Ave, Burnaby Ave, N Ranch Ln, E buckboard Ln, E Laurel Ave, N Chaparral Dr, N Entrada Way, Huerta Verde Rd, N Verano Dr, E Calabria Dr, Orangecrest Ave, and E Becklee Rd.

Fund allocated for this street improvement project is \$200,000.

## Plan 1317 & 1329: Cullen St– Street Improvements

The project resurfaces 50,000 square feet of street improvements on Cullen Street, approximately 0.44 lane miles. Street improvements include, but not limited to, pavement rehabilitation, concrete sidewalk repairs, curb and gutter repairs, ADA compliant curb ramps, signing, and striping. This project will provide a new smooth street to the residents, reducing maintenance costs and elevating the appearance of the area.

Fund allocated for this street improvement project is \$200,000.
